A two day seminar (12.5 hours) is scheduled for Thursday and Friday February 19 and 20, 2015 at Riverview Town Hall / Gunningsville Room, 30 Honour House Court, Riverview, NB, for people who would like to understand how the revenues of their communities can be substantially improved (24 times more) and the revenues of the developers/builders to be at least 4 times higher, and still protect more than 50% of the properties to develop. Attendees at the presentation will learn how they can use the proposed approach in order to build sustainable communities with design that can improve the local economy, provide more affordable housing, reduce infrastructure and services costs to citizens, respond practically to all social issues that citizens can raise, and still protect a substantial portions of the natural environment that communities wish to protect. Through this seminar, attendees will also understand why it is important to implement Smart Growth principles, adapt to Generation Y (born between 1982 and 2000) demands, and find the world 'niche' of the community.

This seminar is particularly suited to all elected officials, administrators in communities, builders/developers of subdivisions, bankers, development officers, real estate agents, civil engineers, planners, surveyors, and experts in health, social development, economy and people who have an interest in building sustainable developments in their community. Daniel Savard, is facilitating research and development in planning for the Department of Environment and Local Government. He is a senior planner with the Province of New Brunswick. He has a Master of Urban Planning degree from McGill University, a Master of Business Administration from the University of New Brunswick, and a Bachelor 'ès science' in geography from Université du Québec à Montréal. During his years of work in the field of planning for sustainable communities, he coordinated the implementation of the first Sustainable Community Design (SCD) subdivision project in the Province at 'Le Village en haut du Ruisseau' (Dieppe, NB), which received numerous national and international awards and recognitions.

Through the *Sustainable Communities Partnership*, Mr. Savard is the main facilitator for the series titled 'Fiscal Impacts & Design,' that help communities and builders to better position their communities and developments to 1) encourage more efficient and fiscally responsible developments; 2) attract knowledge workers and affluent retirees to immigrate in their region; and 3) help decision-makers to build more sustainable subdivisions and communities in New Brunswick.
